This is particularly crucial as we have witnessed a rise in calls for service throughout the year. Moreover, recognizing the importance of equipping our officers with the necessary tools, we have focused on updating our aging fleet of police vehicles. 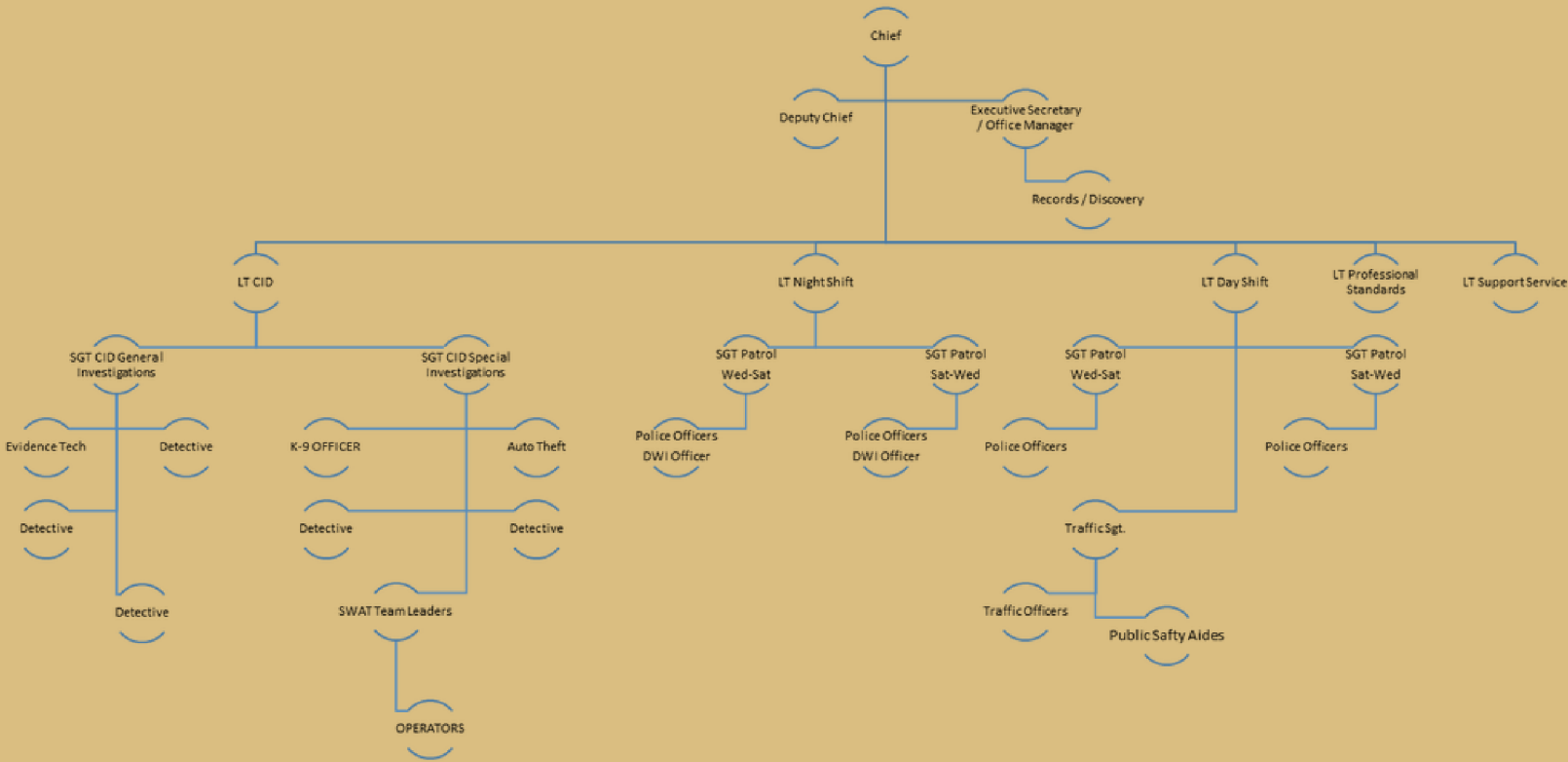
Thank you for your ongoing support, and I look forward to the continued success and growth of our police department in the coming year.

ORGANIZATIONAL CHART

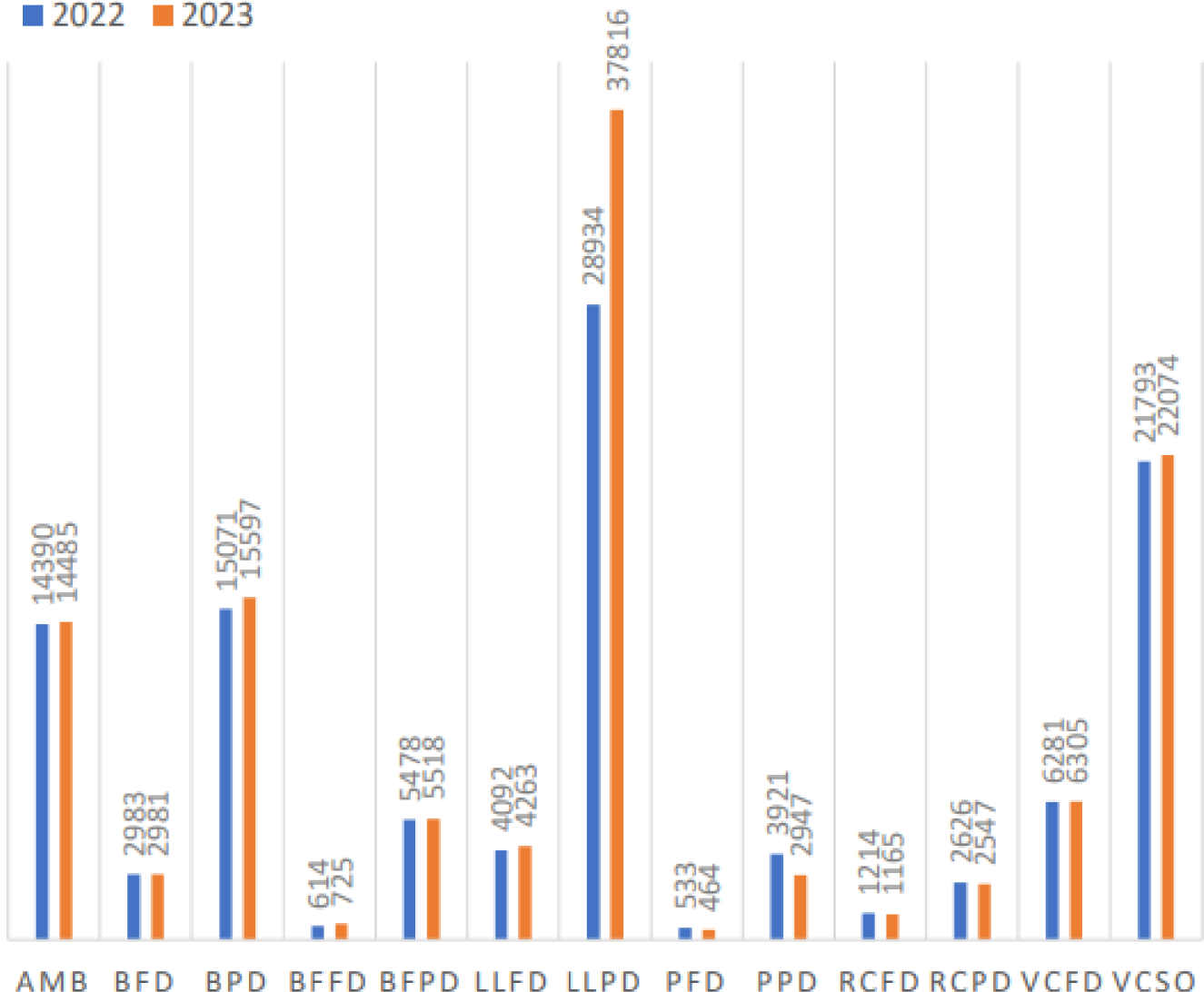


2023 Call For Service Statistics

TOTALS BY AGENCY YTD

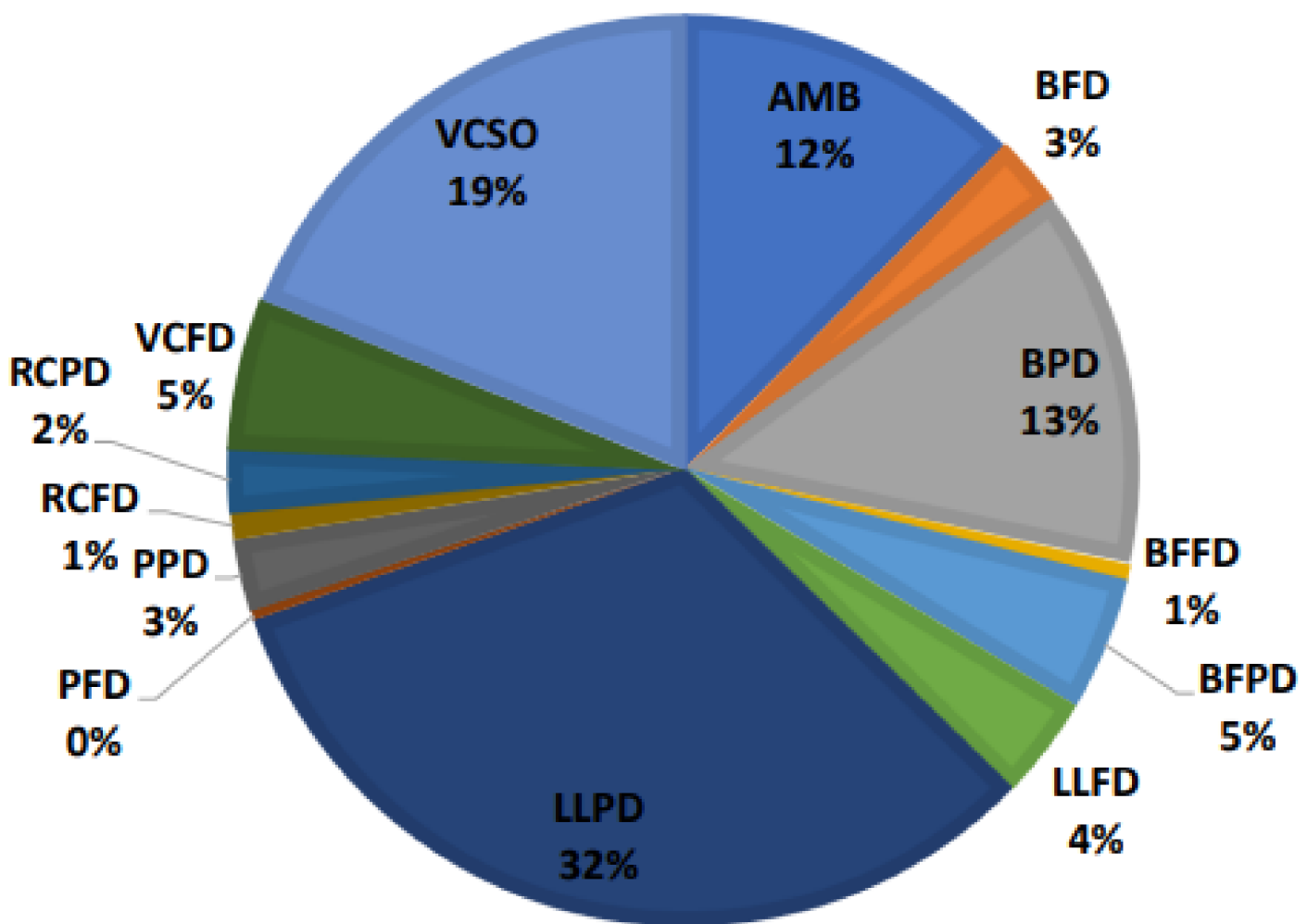

Response to Resistance

The use of force by a police officer is an extremely sensitive issue and requires careful study and understanding by every officer.

Although the careful use of force is authorized by law, the use of unnecessary or unreasonable force is strictly prohibited and is not tolerated.

The Los Lunas Police Department's response to resistance policy permits officers to use only reasonable force necessary to effect lawful objectives in responding to perceived threats. Each time an officer with LLPD uses force, a supervisor will conduct an extensive review of the facts and circumstances surrounding the incident.

Citizen Complaints

The Los Lunas Police Department takes all complaints against our members seriously. The public has a right to expect and demand fair and impartial law enforcement services. In providing these services, department employees must be free to exercise their best judgment and to initiate action in a reasonable, lawful, and impartial manner, without fear of reprisal. While the mutual rights of the public and the police officer are normally respected, situations may arise when these rights are reported to be violated. To protect the rights of the public and our employees, allegations of misconduct must be thoroughly investigated. Outcomes of citizen complaint investigations are classified as:

- **Exonerated**- The behavior in question was proper in all terms of applicable law and department directive requirements.
- **Not Sustained**- Insufficient evidence either to properly or disprove the allegation(s).
- **Sustained**- The allegations are supported by sufficient evidence.
- **Unfounded**- The allegations, upon investigation, are determined to be without bias.
- **Sustained violation not based on the original complaint**- Where the investigation determines, by a preponderance of the evidence, that misconduct did occur that was not alleged in the original complaint but that was discovered during the misconduct investigation.
- **Mediation**- A meeting between the accused officer, the complaint, and the officer`s supervisor.
- **Administratively closed**- Where the policy violation is minor, the allegations are duplicative or an investigation cannot be conducted because of a lack of information in the complaint.
- **Policy Failure**- Where the complaint revealed a policy failure. The allegation is factual and the LEO(s) followed proper agency procedure, however, that procedure has proven to be deficient.

DWI / TRAFFIC UNIT



The Los Lunas Police Department DWI and Traffic Unit works hard everyday to ensure that the roadways we travel on are safe.

The Primary mission of the DWI and Traffic Unit is to reduce the number of traffic-related injuries by taking impaired drivers off the roadway and utilizing visible traffic enforcement in high-volume traffic areas.

The Traffic and DWI unit consists of two officers working nights and two officers working days under the supervision of a sergeant. Officer J. Sedillos and Officer G. Ortiz handle the day shifts which consists of high-volume traffic enforcement and crash investigations. Officer C. Gouker and Officer M. Abeyta work during the nights when the focus is on high-volume traffic enforcement as well as DWI Investigation. They are supervised by Sergeant R. Gray who is an experienced DWI officer and a certified Drug Recognition expert.

Throughout the year the DWI and Traffic Units Participate in different traffic safety enforcement such as STEP (Selective Traffic Enforcement Program), 100 days and nights of summer, click it or ticket, and enforcement checkpoints. These are grant-funded projects that officers work on when they are not on shift to endure the safety of those who are driving on the roadway.



In 2023, The Los Lunas Police Department purchased two Specialized Tero 5.0 E-Bikes. The E-Bikes are a mountain bike with an electric powered motor which can run for several hours on one of three motor assistance modes. Easy to operate and maintain, the bikes are a perfect addition to the fleet of equipment utilized by the officers of the Los Lunas Police Department.

Officers interested in utilizing the E-Bikes on duty will typically attend a 5 day law enforcement cycle course which is hosted by nearby agencies several times a year and follow the curriculum provided by the international police Mountain Bike Association.

The Los Lunas Police E-Bikes allow Officers to easily maneuver in tight spaces, like parking lots and between buildings as well as navigate in areas where a typical police vehicles may not be able to operate. Using the E-Bikes in areas of business as well as in open space area's and the Bosque allow for Officers to approach situations from a different vantage point as well as provide an element of surprise.

The Los Lunas Police E-Bikes can travel at speeds up to 20 MPH with the pedal assists motor and is accompanied by the handlebar LCD Bluetooth capable operations display. The Los Lunas Police E-Bikes are specially equipped with red and blue flashing lights on the front and rear as well as a front headlight and rear red light for safety. An extra 710Wh battery was also purchased and is always available for times of long operation use.

The E-Bikes are easily transported by vehicle if needed using the Thule T2 Pro X 2 bike rack, making the Los Lunas Police E-Bikes limitless in their potential and operational use.

Special Investigations Unit After Action Report (2023)

Operation(s):

Auto Theft, Narcotics, and Retail Theft Location Village of Los Lunas.

Findings:

In the calendar year of 2023, the Special Investigations Division, comprising the Narcotics Division, Auto Theft Division , successfully executed operations within their respective areas of expertise in the Village of Los Lunas . The Following breakdown illustrates the total operations conducted by each division:

Auto Theft Division:

- 12 Vehicles Identification Number (VIN) Inspections
- 22 Auto Theft Operations
- 1 Vehicle Warm-Up Operation

Retail Theft Division:

- 9 Operations conducted at various retail locations within the village limits

Narcotics Division:

- 8 Narcotics Buys, including 3 Intelligence, Surveillance, and Reconnaissance (ISR) Operations

- 180 Live and training missions since start date in October 2023
- 1.7 Million feet in distance traveled
- 50 Plus Hours in the air
- 1 UAV Search Warrant served (First in LLPD History, CID Wrote Warrant)
