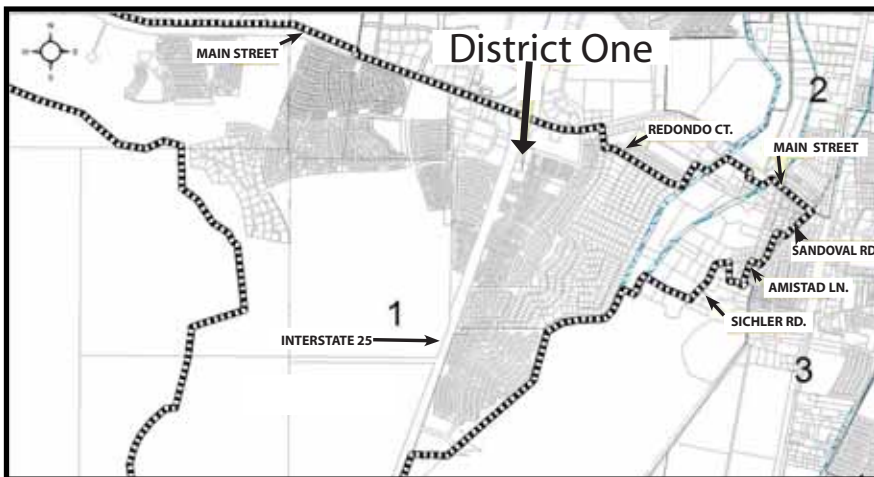

Candidates File January 8; Districts 1 & 3 Vote March 4



All Declarations of Candidacy for the two Village Council seats which will be voted on March 4 must be filed Tuesday January 8, between 8 AM and 5 PM.

Voters in Districts One and Three in the Village of Los Lunas will go to the polls March 4 to vote for a councilor who will represent their district the next four years.

Current councilors for these districts are Cecilia CC Castillo, District One, and Gerard Saiz, District Three.

The polling site for the March 4 election will be the Village Administration Building located at 660 Main Street, the corner of Don Pasqual and Main Street. Polls will be open from 7 AM to 7 PM Tuesday March 4.

Absentee ballot applications will be available at the office of the municipal clerk at the Administration Building beginning Wednesday, February 6. Applications for absentee ballots must be completed and accepted prior to 5 PM February 29.

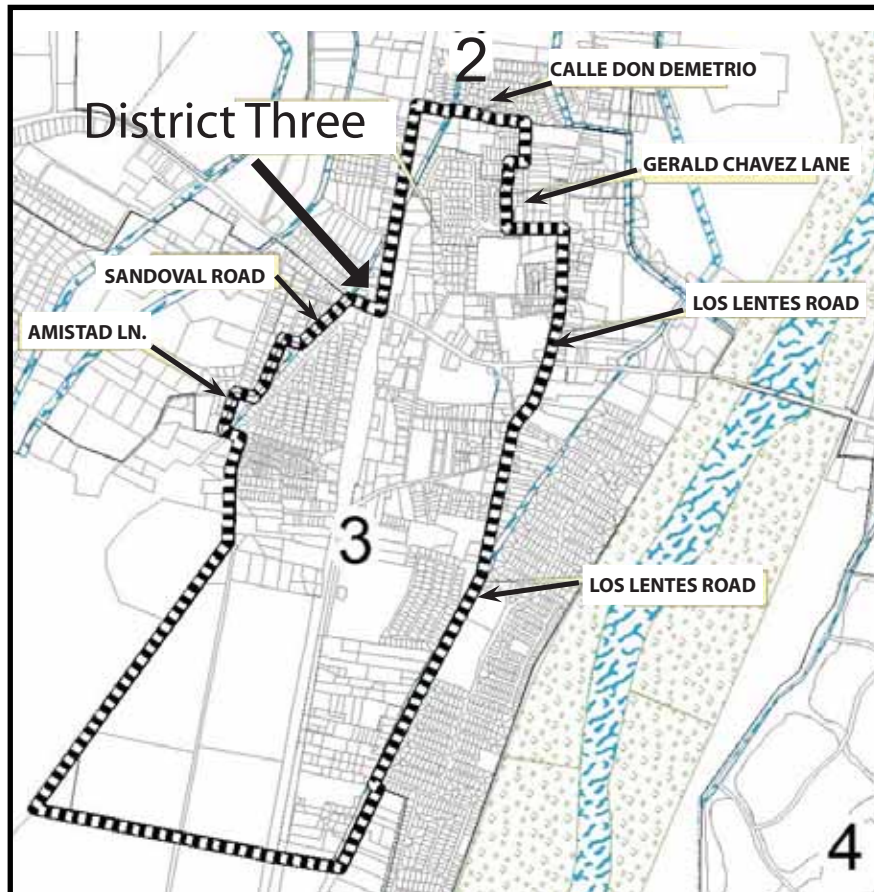
Completed absentee ballots will be accepted until 7 PM March 4.

Absentee voting by machine will be conducted at the Administration Building beginning at 8 AM Wednesday, February 13 and closing at 5 PM February 29.

Anyone wishing to register to vote so that they may vote in this election must register with the Valencia County Clerk not later than Tuesday, February 5 which is the date the registration books will close.

To the left are maps of Districts One and Three which were created after the 2000 Census. Only people who live within these areas will vote in the 2008 election.

Time to Renew Business License

If you had a business license in 2007 then you should have received the renewal notice for that license. Although the license does not have to be renewed until March 15 many people renew the license as soon as they receive the notice.

All businesses, whether Mom and Pop or multi-national, pay the same fee, \$25.

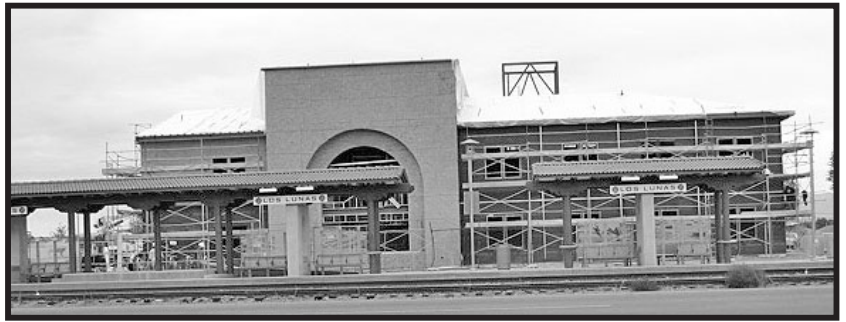
Los Lunas Station Area Planning Continues

A public open house held on November 8th presented revised land use and transportation ideas for the area within one-half mile around the Los Lunas Rail Runner station.

According to Art Mondragon, Village Planning Director, the planning effort will identify how the Rail Runner station can “support our local business, provide housing options for current and future residents, and make our Village a better place for residents and visitors.”

The planning team presented recommendations including:

- Pedestrian and bicycling improvements – such as bike lanes and pedestrian crossings – to help people walk and bicycle safely and conveniently between the Rail Runner station and businesses and homes.
- Street designs for some key station area streets – including Luna Ave., Courthouse Road, and NM 314 – that will make the area more inviting, enjoyable, and convenient for residents and visitors
- A shuttle route providing service between the station and the surrounding area.
- Encouraging housing and business types, styles, and designs that will make the station area a focal point of the village.
- A “mixed use core” in the area nearest the station that includes residences, businesses, and public uses.
- A residential district in the remainder of the one-

half mile area that focuses on housing and supports the Rail Runner and the activities in the station area.

- Guidelines to encourage that any new development that occurs in the area includes mixed income housing, is pedestrian oriented, and compliments the existing neighborhoods around the station.

The ideas presented at the open house will be included in a plan to be introduced to the Village council for consideration. The plan will serve as a guide for the Village when considering land use proposals, infrastructure investments, and policies that may impact the station area.

New Look Website Has More Information

One of the additions to the site is email alerts which sends items such as the council agenda to recipients as soon as the agenda is posted.

Items retained on the website include online bill pay, report a crime, agendas and the ability to contact people by email at village offices.

The online forms and applications sections has been expanded and now includes:

- Administrative Department — council agenda request form, application for utility service and bank draft authorization for paying utilities.
- Community Development Department — code enforcement complaint form and report water waste.
- Parks and Recreation — graffiti removal form, mosquitos spraying request form and youth sports facility agreement.

- Police Department — Neighborhood Watch report and complaint form.

Street Department — pothole and sidewalk repair form and street light repair form.

- Community Development — applications for building permit, business license, conditional use, final plat, home occupation registration, liquor license, lot split, mobile home, preliminary plat, re-plat, sign permit, variance, vendor permit and zone change.

The village website has links to the Valencia County Chamber of Commerce, Los Lunas Public Schools, Los Lunas Schools' Partners in Education, Valencia County and the New Mexico Rail Runner.

A calendar provides dates for village events including council and planning and zoning meetings.

Village Police Cars To Have Laptop Computers

Laptop computers will soon be working away in several Village of Los Lunas police units thanks to a federal Department of Justice grant.

A total of \$47,004 was awarded to the Los Lunas Police Department and the Valencia County Sheriff's department by the Edward Byrne Memorial Justice Assistance Grant program.

Both law enforcement agencies expect to use the funds to improve current law enforcement technology including laptops which will allow officers to transmit and receive information from the field more quickly.

The grant is to be divided with \$30,617 going to Los Lunas and \$16,387 for the sheriff's department.

Los Lunas department officials say they are looking at durable and rugged computers which will be compatible with the village's Wi-Fi system.
