Pardon Our Progress — Projects Continue

Work continues on the village's road improvement projects, says Public Utilities Director James Blasing who points out that the progress of any road project depends on the weather.

The work on the intersection of NM314 and Main Street (also known as NM6) will continue once signal equipment has arrived. The American Recovery and Reinvestment Act projects on the east and west side of south NM314 are ongoing.

The sewer force main replacement project on the bridge over the Rio Grande has started and is progressing well.

Bring Your Library Books in On Time! Fees Start April 1

The Los Lunas Public Library will begin charging late fees on all items on April 1.

The fees will be 15¢ per item per day. This means if a family has 20 items one week overdue then the charge would be \$21. Ten items four days overdue would be \$6.

The fee starts the fourth week which gives library patrons a week grace period to bring items in.

The fee on videos and DVDs is also 15¢ per day but these items can only be checked out for one week.

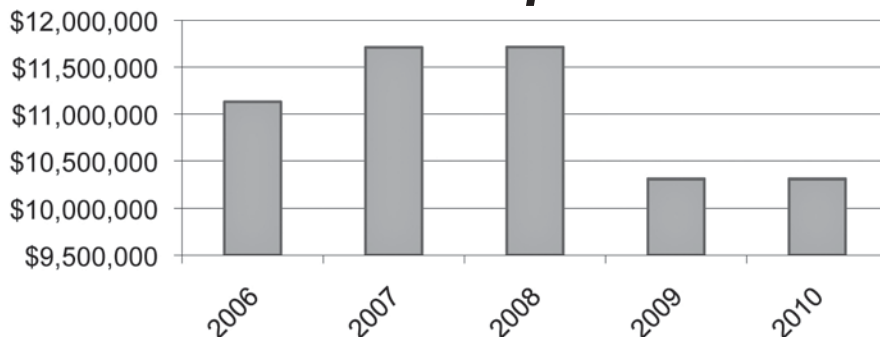

Animal control officers encourage people to keep pets, but make sure they are the right kinds of pets for New Mexico and for a home environment.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

The Los Lunas Water System has a level of Arsenic above Drinking Water Standards for the fourth quarter of 2010

Our water system recently violated a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what happened, what you should do, and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Testing results from quarterly routine arsenic samples indicate that Well # 3 did not meet the Running Annual Average of MCL's for arsenic. The quarterly samples are as follows for Well #3:

A sample collected during the first quarter 2010 on March 24, 2010 had a result of 15ppb.

A sample collected during the second quarter 2010 on April 28, 2010 had a result of 14ppb.

A sample collected during the third quarter 2010 on July 21, 2010 had a result of 8ppb.

A sample collected during the fourth quarter 2010 on October, 19, 2010 had a result of 6ppb.

These 4 sample results produce a Running Annual Average of 11ppb. The standard for arsenic is 0.010 mg/L or 10ppb and is based on the Running Annual Average of these four consecutive quarterly samples. Therefore, the Los Lunas Water System in Well #3 has exceeded the arsenic MCL in the fourth quarter by 1ppb.

What should I do?

You **DO NOT** need to use an alternative (e.g., bottled) water supply. However, if you have specific health concerns, or have a compromised immune system you may consult your doctor or drink and use bottled water.

What does this mean?

This is not an immediate risk. If it had been, you would have been notified immediately. However some people who drink water containing arsenic in excess of the MCL over many years could experience skin damage or problems with their circulatory system, and may have an increased risk of getting cancer.

What happened? What is being done?

The arsenic in our water is from the erosion of natural deposits. The Los Lunas Water System will continue to post this arsenic public notice every 3 months as long as this MCL exceedence persists. The arsenic treatment facilities are complete and online **The most recent tests show levels in the water are below the 10 ppb in all Wells**, however compliance is based on an annual average and until the lower levels currently pumped lowers the annual average the notice of violation will be sent out.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people doing business with your establishment, temporary workers or visitors, etc.). You can do this by posting this notice in public places and distributing copies by hand or mail.
