Street Signs Easier On Eyes

When you travel through the village you will eventually see changes in traffic signs, changes intended to make the signs easier to see, especially at night.

The focus of changing the signs is increasing the retroreflectivity, a ratio of the amount of light returning from a sign versus the amount hitting the sign.

Retroreflectivity provides nighttime guidance for drivers, guidance which may be especially needed by older drivers. In 1990 10.7 million drivers were 70 or older while there were 20.6 million drivers 70 or older in 2006, a 48 percent increase.

In addition to the increased retroreflectivity, street signs will now be designed with upper and lower case letters rather than just upper case. This means that Mesa Loop would be spelled Mesa Loop rather than MESA LOOP on a sign.

This change is being made because people are used to reading in upper and lower case rather than all upper case.

Signs which will not be changed include parking/standing/stopping, Adopt-A-Highway, and those with blue or brown backgrounds.

Sidewalk and pedestrian improvements will be taking place on Camelot Boulevard during February and March, weather permitting. Please be patient as the contractor, G. Sandoval Contracting, makes changes to the traffic pattern while doing the work.

The polling site for the election is the Village Administration Building, Don Pasqual and Main Street, where the polls will be open from 7 a.m. to 7 p.m. on Tuesday, March 6.

Only registered voters in District One and Three can vote in the March election. Voters will vote only for the councilor who will represent their district.


Absentee ballots can be issued starting January 31. Voter registration closes at 5 p.m. February 7.




2012 Reminder — Two Animals Per Household

With a new year here's a reminder from the municipal code — "No person or household shall own, harbor or keep more than two dogs or cats in any combination thereof over the age of three months on property less than one-half acre in size. In the event the property is greater than one-half acre in size, the person or household may own, harbor or keep up to four dogs or four cats, or any combination thereof only if the property is zoned Agricultural/Residential."
