

Village Council Approves 2014-2015 Interim Budget

The Village Council has approved an interim budget for the 2014-2015 year that begins July 1 which includes capital outlay projects, cost of living adjustments for employees, and a change in employee medical insurance coverage.

Capital outlay projects include improvements to Los Cerritos Road from Main Street to Highline Street; another section of Carson Drive; Courthouse Road; and Highway 314 south of Courthouse Road on both sides. Improvements will also be made to the Village's Sports Complex (soccer fields), as well as to the I-25 interchange.

Phase Two of the Village Transportation Center is scheduled to be completed in 2014-2015. Installation of new cassettes at the wastewater treatment plant is slated for 2014-2015. A \$1.9 million state appropriation will help pay for the cassettes.

Full time and part time permanent Village employees will receive a 1.5 percent cost of living adjustment

Work Scheduled on Los Cerritos

Los Cerritos Road will be improved after the Village Council awarded the contract for the job to Desert Fox LLC for \$142,819.54.

Work includes sidewalk and pavement improvements as well as new striping.

The improvements will be done on Los Cerritos from Main Street/Highway 6 north to Highline Street.

The Village will continue to cover 100 percent of an employee's medical insurance, but employees will begin paying a percentage of their dependents' medical insurance coverage based on their salary level.

The Village's 2014-2015 general fund revenues are budgeted at \$14.6 million while general fund expenditures are budgeted at \$14.8 million, not including transfers, the balance coming from general fund reserves.

The Village's interim budget had to be submitted to the New Mexico Department of Finance and Administration (DFA) by the June 2 deadline for approval. The Village's final budget is due to DFA by August 1.


