## BOND APPROVAL WOULD IMPROVE FIRE FACILITIES, EQUIPMENT

**All registered voters in the Village of Los Lunas are eligible to vote on the General Obligation Bond question on the March 1, 2016, ballot.**

The bond issue question is "Shall the Village of Los Lunas issue up to \$5,795,000 of general obligation bonds, to be repaid from property taxes, for the purpose of providing fire protection including purchasing apparatus for fire protection and providing, enlarging and improving fire protection equipment and facilities?"

Early voting opened Wednesday, Feb. 10, while voters can absentee vote now.

Passage of the G.O. Bond would mean a second fire station on the west side of Los Lunas off Sandsage.

Currently the main station is at 465 Main Street SE with a

substation located in facilities at the former Los Lunas Hospital and Training School.

Fire Chief John Gabaldon said the Village needs an additional fire station to:

- increase and improve the current level of fire and emergency medical services
- preserve prompt and consistent response times for emergencies
- obtain new firefighting equipment for the new fire station
- maintain fire prevention efforts throughout the community.

Chief Gabaldon said a second fire station will help efforts to maintain current insurance ratings while continuing to work on lowering them. Lower ratings result in lower fire insurance rates.

The polling site for the March 1, 2016, election is the Village Administration Building, 660 Main Street NW, from 7 a.m. to 7 p.m.

Only registered voters may vote in this election.

Nonresidents owning property within the Village limits are eligible to vote on the G.O. Bond question on Election Day because G.O. bonds affect property taxes.

Property owners must contact the Valencia County Clerk/Bureau of Elections, 505 866-2080, to express their desire and certify their eligibility to vote.

## VILLAGE COUNCIL DISTRICT ELECTION

Three candidates are running for Village Council in the March 1, 2016, Village election.

District One candidates are Christopher S. Ortiz and Amanda M. Perea.

District Three candidate is Gerard Saiz.

# VOLUNTEERS WORK ON TRAILS AT EL CERRO PRESERVE

**Looking for a place to hike, or just walk, that's close to home and offers fantastic views?**

El Cerro de Los Lunas Preserve offers 1,444 acres of natural open space that can be used for running, jogging, or walking.

El Cerro is the hill on the west side of Los Lunas.

The Village recently honored two citizens who have been instrumental in fixing and maintaining preserve trails.

Niles McCall and Jeff Caldwell have worked on more than five miles of trail since November 2014.

Mayor Charles Griego and Village council members thanked these volunteers for their work at a recent Council meeting.

# TRANSPORTATION CENTER UNDERGOING CHANGES

**The Village Transportation Center, sometimes called the New Mexico Rail Runner Express Station, will undergo dramatic changes this spring and summer.**

The area directly to the north of the building will be transformed into a plaza with street furniture and other amenities. Parking will no longer be allowed in this area.

Additional parking will be constructed in the lot to the north across Courthouse Road.

Changes will also be made to the configuration of the parking lot located east of the building.

The drop off point will be changed to make it more convenient.

A separate area will be created for staging the public transportation shuttles.

The cost is \$1,035,000 for the earth and concrete work plus an extensive landscaping program will be \$298,758.

A \$1,000,000 grant from the Federal Transit Administration and a \$100,000 grant from Housing and Urban Development provide the bulk of the funding for the improvements. The remainder of the cost is allocated in the Village budget as a match.

The Transportation Center opened in 2008 with Village offices, meeting rooms, a café, and a station for the New Mexico Rail Runner Express.

# KING OF THE HILL RUN MARCH 12

**The Second Annual King of the Hill 5K/10K** trail run will be held Saturday, March 12, beginning at El Cerro de Los Lunas Preserve Trailhead, located 3 miles west of I-25 on Highway 6 in Los Lunas.

The 5K takes the participant along the “Bowl Trail” on the west side of El Cerro de Los Lunas Preserve. It is mostly a flat course with a few small hills.

The 10K begins on the same route as the 5K and then diverts up a steep hill to meet the Overlook Trail, which offers breathtaking views of the Rio Grande Valley.

The 10K runners descend the hill and meet back up with the 5K course to finish. The 10K has approximately 700 feet of elevation change.

The 10K race starts at 9 a.m., 5K at 9:30 a.m. Awards ceremony scheduled at 10:30 a.m.

# RATE INCREASE STARTS THIS MONTH

A reminder — Village of Los Lunas water and sewer bills sent in February 2016 reflect a slight increase in those charges as part of a five-year plan approved by the Village Council in December 2014.

The Council approved the five year water and sanitary sewer rate increase to both the base usage charge (0 – 2000 gallons) as well as the per thousand gallon usage charge above the base usage charge.

The rate increases are necessary to generate adequate revenue to meet existing water and sanitary sewer operational and maintenance costs; increasing costs for water supply treatment, sanitary sewer treatment, water distribution and sanitary sewer collection system maintenance; and proactive management for planned water and sewer system capital improvement projects.

The rate increases are being phased in over five years. The first increase was reflected in the February 2015 billing.

Village commercial sanitary sewer usage is determined as equal to the water meter reading.
