FILL OUT WATER CONSERVATION SURVEY

Take a few minutes to fill out the Village of Los Lunas water conservation survey available at <http://www.loslunasnm.gov/wcpsurvey>.

The goal of the survey is to help provide awareness, offer an opportunity to provide feedback, and guide future conservation efforts in the community.

It takes only a few minutes to fill out the survey.

Survey results will become part of the Village's water conservation plan.

The water conservation survey will be available online until March 27, 2017.

The water conservation plan describes the progress made by the Village implementing water conservation actions identified in the 2010 Forty Year Water Development Plan.

WATER SOURCE PROTECTION PLANNING

Village officials worked with Daniel B. Stephens & Associates, Inc. to develop a Source Water Protection Plan (SWPP).

The SWPP provides the management tool for current and future approaches to prevent source water contamination, thereby protecting the Village drinking water system and customer health.

The SWPP says that by 2050 the Village water system will serve 43,662 residents and 1,500 inmates at the Central New Mexico Correctional Facility.

The Village's 40-year-plan shows adequate water supplies into the future.

RECYCLING SITE CHANGES



The Village recycling site is moving, but not very far, just north of the current site.

More and more people recycle which means the recycling site is moving to accommodate the increased usage.

A new recycling facility is being constructed. No shut down of the recycling area is anticipated during the construction.

The Village's Solid Waste Division personnel will move to the transfer station on Highway 6 west of I-25.

Also moving to the transfer station are the Solid Waste Division equipment and the old First Choice building from South Highway 314 to serve as new office space.

Be careful driving into the recycling area as there will be the reconstruction of the recycling center and the construction of the Valencia Regional Emergency Communications Center.

HIGHWAY 6 & 47 IMPROVEMENTS

Work is expected to begin soon on improvements to the intersection of NM Highway 6 (also known as Main Street) and Highway 47.

The \$484,108 project includes installation of new traffic signals, new signage, and other traffic items as needed to improve vehicular traffic flow and pedestrian safety including ADA improvements..

Funding for the project is 100 percent provided by the Highway Safety Improvement Program with no funds provided by the Village.

Bixby Electric was awarded the project contract by the Village Council.

Be extra cautious in this area during construction. Watch out for workers.

VALENCIA COUNTY SENIOR FITNESS

Registration for the Valencia County Senior Fitness 100 has begun.

The event encourages citizens age 50 and up by Dec. 31, 2016, in Valencia County to log as many miles of exercise as they can in the 100 days between Feb. 15 and May 25.

INCREASES TO WATER/SEWER RATES

A reminder — Village water and sewer bills sent in February 2017 reflect a slight increase.

The increases are:

- 0-2000 gallon water usage increase of \$1.59 or \$21.43 base rate; and
- 0-2000 gallon sanitary sewer increase of \$2.00 or \$27.08 base rate.

Water and sewer usage per thousand above 2000 gallons will have no increase to the current calculation of \$4.25 per thousand for water and \$3.75 per thousand for sewer.

Village water usage charges are based on a metering system.

The Village residential sanitary sewer usage is determined by taking the average water usage from November through February and shows in the April statement.

Village commercial sanitary sewer usage is determined as equal to the water meter reading.

KING OF THE HILL MARCH 11

The 3rd Annual King of the Hill 5K/10K and half marathon trail run will be held Saturday, March 11, starting at El Cerro de Los Lunas Trailhead, three miles west of I-25 on Highway 6.

The 5K goes along the Bowl Trail on the west side of El Cerro and is mostly a flat course with a few small hills.

The 10K begins on the 5K route before diverting up a steep hill to meet the Overlook Trail, which offers views of the Rio Grande Valley and the Sandia and Manzano Mountains.

The 10K has approximately 700 feet of elevation change.

The Half Marathon has 2100 feet of elevation gain/loss covering the 10k overlook trail and continues to the east side of the Los Lunas Hill.

FACEBOOK DATA CENTER BRINGS ECONOMIC DEVELOPMENT

A study prepared by David Taussig & Associates, a California based consulting firm retained by the Village, projects significant fiscal and economic impacts over a 10-year period for the new Facebook data center in the Village.

The document is dated December 2016.

The report states that the goal of the study was to "determine whether the project is expected to generate enough revenues for the Village to fully offset expenditures for Local Economic Development Act (LEDA) assistance as well as services provided on its behalf by the Village."

The study says:

- Total economic output over 10 years — the temporary impacts of the construction project, and the more permanent impact of the data center, are projected to reach \$1.88 billion if "indirect and induced" impacts are also included. That number reflects the creation of 5,660 jobs countywide and the addition of \$234.77 million in wages.



- Assuming the maximum six buildings are constructed, the project is expected to generate a net of \$2.17 million per year in revenue for Los Lunas's general fund, \$21.71 million over 10 years

- Los Lunas is expected to net nearly \$28 million in gross receipts tax revenues related to the construction project over a decade-long period, a figure that accounts for the amount forgiven in the incentive package. Gross receipts tax revenues countywide are projected to total \$83.41 million over the same period.

- The project will require "significant new infrastructure . ultimately owned by the Village and maintained by the Village's general fund" and "financed through public or private funds," including water main extensions, additional fire hydrants and sewer improvements.

PNM is also building a high-voltage electrical line and several solar facilities for the data center.
