COVID-19 PANDEMIC RULES SHOPPING

It looks like we will continue to deal with the COVID-19 pandemic during the upcoming Thanksgiving and Christmas holidays.

If you are going shopping then remember the COVID-19 safe rules for going out:

- Individuals are required to wear a face covering or mask in public spaces except when eating, drinking, or swimming, or unless otherwise advised by a healthcare provider.
- Maintain a six-foot distance from others.
- Avoid gatherings.
- Protect vulnerable populations by finding ways to connect without face-to-face contact.

Village Economic Development Manager Ralph L. Mims reminds people to shop in Los Lunas and Valencia County. "When you shop locally you help the whole community, especially now," said Mims.

Show your support for local businesses and restaurants as much as possible.

As you show support, remember that the Village of Los Lunas continues to provide its usual services, but with changes to protect people from the coronavirus.

And remember the at-home COVID-19 safe rules:

- Avoid unnecessary travel and always stay at home when you are sick (except for medical emergencies).

- Wash your hands frequently.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- All meetings should take place remotely whenever possible.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.

VILLAGE HOLIDAY EVENTS CANCELED

The Village annual Christmas Electric Light Parade and Village Tree Lighting Ceremony with Santa Claus have been canceled.

The cancellation is due to the COVID-19 pandemic.

Holiday events are coordinated and presented by the Village Parks and Recreation Department.

GRANTS AWARDED

Village businesses impacted by COVID-19 public health orders received CARES Act Small Business Grants.

The grants are intended to cover business continuity expenses, business redesign expenses, and all expenses that fit into these categories: non-owner employee payroll, rent, scheduled mortgage payments, insurance, utilities, marketing, installing plexiglass barriers, purchasing web conferencing or other technology to facilitate work-at-home, and employee PPEs.

The Village was able to award nearly the full requested funds to each eligible business.

CITIES READINESS INITIATIVE

The Los Lunas Fire Department is looking for volunteers for the Center for Disease Control's Cities Readiness Initiative (CRI), a federally funded program designed to enhance preparedness in the nation's large population centers where more than 50% of the U.S. population resides.

Using CRI funding, state and large metropolitan public health departments develop, test, and maintain plans to quickly receive and distribute life-saving medicine and medical supplies from the nation's Strategic National Stockpile (SNS) (<https://www.cdc.gov/phpr/stockpile/stockpile.html>) to local communities following a large-scale public health emergency.

Initially, the CRI planning scenario was based on a response to a large-scale anthrax attack; however, it became apparent that CRI jurisdictions must be prepared to respond to other public health emergencies.

The Pandemic and All-Hazards Preparedness Reauthorization Act emphasized an all-hazards approach to public health preparedness planning, thereby expanding the scope of the CRI planning to include natural and man-made public health threats.

Part of this planning and preparedness is developing and maintaining plans for a staging area to receive and distribute Medical Countermeasures (MCM) and Points of Dispensing (POD) to dispense the MCMs.

Volunteers are needed to serve functions from traffic control to registration to treatments and more. This video offers more information <https://www.youtube.com/watch?v=TwBKAPzunT4>.

What is the benefit of becoming a CRI volunteer?

- You and your immediate family are administered prophylaxis ahead of the general public.
- FREE training in Incident Command, SNS and CRI processes.
- Giving back to your community.

What is required as a CRI volunteer?

- Participate in quarterly call-down exercises where you respond with a YES or a NO answer.
- Annual training / refresher in POD activation

SHORT-TERM RENTAL REGULATIONS

The Village Council approved Short-Term Rental regulations at the Oct. 8, 2020, Council meeting.

These regulations allow short-term rentals, like Airbnb, as an accessory use in any residential zone, as long as the owner/operator registers as a business and obtains a short-term rental permit from the Community Development Department.

The new regulations also allow the Village to collect lodgers' tax from short-term rentals, similar to a hotel or RV Park, and they provide enforcement measures if either the renter or the property owner are found to violate any Village ordinances, such as noise or nuisance regulations.

Short-term rental permits can be obtained starting Dec. 1, 2020.

Any property currently operating as a short-term rental must apply for a permit no later than March 15, 2021. Contact the Community Development Department at 505 352-7659 with any questions.

RENEW YOUR BUSINESS REGISTRATION

Now is the time to purchase or renew your business registration for the Village of Los Lunas, says Community Development Director Erin Callahan.

All businesses, multi-national or Mom and Pop, home-based or otherwise, pay the same fee, \$25.

DRIVE-IN MOVIES ON HOLD

The Village's plan to bring drive-in movies to Los Lunas has been put on hold due to issues with the equipment, but work continues on the project.

The drive-in theater would have filled a need for additional things to do in the Village that fall under the public health orders during the COVID-19 pandemic.

The village purchased an FM transmitter so patrons could listen to the sound of the movie on a vehicle's radio.

Capacity of the theater was expected to be about 100 cars.

WORK STARTS ON NEW WELL

Desert Fox LLC has started the site development work required for the Village's Well #7 located at 2609 Purple Sage in Los Morros Industrial Park.

The job includes arsenic treatment and water-sewer offices.

The cost is \$687,000 and will be paid by State LEDA (Local Economic Development Act) funds.

In addition, the contractor will be installing all water, gas and sewer lines associated with the three buildings to be constructed.

MORE READING MATERIALS FOR YOUTH, TEENS

The Los Lunas Public Library recently purchased two eBook platforms to provide access to reading materials for the youth and teens of the area.

While adult patrons can download eBooks and eAudiobooks at New Mexico Library to Go: <https://nm.overdrive.com/> the selection for youth and teens is very limited.

To address this limitation, the Los Lunas Public Library purchased access to Tumble Book Library and Teen Book Cloud utilizing New Mexico General Obligation Bond funds.

Tumble Book Library is an online database of over 1,100 titles for grades kindergarten through sixth, and includes unique animated, talking picture books, graphic novels, read-along chapter books, National Geographic videos, non-fiction books, playlists, as well as books in Spanish and French.

The collection is available online around the clock. No downloads, no waiting!

Teen Book Cloud is an online database of eBooks and educator resources perfect for middle school and high school students. The database offers a robust selection of graphic novels, enhanced novels, eBooks, classic literature, National Geographic videos, educator resources, and audiobooks.

The collection is available online around the clock as well.

General Obligation Bond funds are voted upon by New Mexico voters every two years to help support public, school, academic, and tribal libraries in the state in providing services to the public. A GO Bond was on the Nov 3, 2020, ballot in the amount of \$9,500,000.

Library Director Cynthia Shetter says the Los Lunas Public Library is proud to use taxpayer-approved funds to help provide services to youth and teens during the COVID-19 pandemic. For more information on accessing any of these databases, call the public library at 505 839-3850.

MUSEUM OF HERITAGE & ARTS CLOSED

The Museum of Heritage & Arts is closed to the public to help curb the spread of COVID-19 in the community.

The decision to close was based on current attendance, the recent spike in positive COVID-19 cases, and on Governor Michelle Lujan Grisham's Oct. 19, 2020, announcement to amend public health orders and close state museums and historic sites.

Museum staff will be on site Monday through Friday offering curbside services. In addition, staff will be posting exhibits, and items of historic / artistic content on the museum Facebook page at <https://www.facebook.com/loslunasmuseum>.

The Museum's Juried Art Show exhibition is scheduled to run Nov. 14, 2020, to Jan. 9, 2021. Due to the closure the exhibit will be photographed and presented virtually until the closure is lifted.

Construction continues on the Museum's event patio on the south side. The patio structure has been installed. There are a few tasks to be completed and the patio may be done by mid-November.

LLPD AWARDED GRANTS

The Los Lunas Police Department has been awarded the Edward Byrne Memorial Justice Assistance Grant (JAG 2020) in the amount of \$11,803.

The JAG program is the leading source of federal justice funding to state and local jurisdictions.

The award will purchase a crash diagramming software, and basic motorist assist tools/equipment to help stranded motorists.

In addition, the United States Department of Justice – Office of Justice Programs - awarded the Village funding entitled BJA FY 20 Coronavirus Emergency Supplemental Funding Program in the amount of \$37,935.

Funding will be applied towards equipment that enhances remote work stations and PPE.
