## NO TEXTING WHILE DRIVING IN LL

It is now unlawful in the Village of Los Lunas for any person to operate a motor vehicle upon a street or highway while using a mobile telephone, or other electronic device, to create, send, or read a text or instant message, or receive or transmit data, including but not limited to photographs, snapshots or electronically transmitted images, or any other data, whether the vehicle is in motion or not.

The exception is use of a mobile telephone for the sole purpose of communicating with any of the following regarding an emergency situation:

- an emergency response operator.
- a hospital, physician's office or health clinic.
- an ambulance company or corps.
- a fire department, district, or company.
- a police department or sheriff's office, including any law enforcement office and police officers while in the discharge of their official duties.
- emergency services officials, first aid, emergency medical technicians and personnel, or any fire safety officials in the performance of duties arising out of and in the course of their employment.

Also an exception is the use of a hands-free mobile telephone when used in a hands-free manner.

The ordinance passed by the Village Council does not authorize the seizure or forfeiture of a handheld mobile communication device.

The handheld mobile communication device used in the violation of the ordinance is not subject to search by a law enforcement officer during a traffic stop made under provisions of the ordinance.

Definitions in the ordinance include:

"Driving" means being in actual physical control of a motor vehicle on a highway or street and includes being temporarily stopped because of traffic, a traffic light or stop sign, or otherwise.

"Driving" excludes operating a motor vehicle when the vehicle has pulled over to the side of or off of an active roadway and has stopped at a location in which it can safely remain stationary.

"Text message, instant message, data, photographs, electronic images and snapshots" means a digital communication transmitted or intended to be transmitted between communication devices and includes electronic mail, an instant message, a text or image communication and a command or request to an Internet site; but "text message" excludes communications through the use of a computer-aided dispatch service by law enforcement or rescue personnel.

Upon the conviction or plea of nolo contendere for a violation of the ordinance the person shall be fined as follows:

- Every person under first conviction of this section shall be fined \$50;
- Every person who is convicted or pleads nolo contendere to a second violation of this section shall be fined \$100; and
- Every person who is convicted or pleads nolo contendere to a third and all subsequent violations of this section shall be fined no less than \$150 or more than \$500.

## THE VILLAGE MUNICIPAL CODE

The Los Lunas Municipal Code is organized to make the laws of the village as accessible as possible to village officials, village employees, and citizens.

It's easy to familiarize yourself with some important elements of this code.

The code is organized by subject matter under an expandable three-factor decimal numbering system designed to facilitate supplementation without disturbing the numbering provisions.

Each section number designates, in sequence, the numbers of the title, chapter, and section. This means Section 2.12.040 is Section .040, located in Chapter 2.12 of Title 2.

In most instances, sections are numbered by tens (.010, .020, .030, etc.), leaving nine vacant positions between original sections to accommodate future provisions.

Similarly, chapters and titles are numbered to provide for internal expansion.

In parentheses following each section is a legislative history identifying the specific sources for the provisions of that section.

This legislative history is complemented by an ordinance disposition table, following the text of the code, listing by number all ordinances, their subjects, and where they appear in the codification; and beginning with Supplement No. 20, legislation can be tracked using the "Code Comparative Table and Disposition List."

A subject-matter index, with complete cross-referencing, locates specific code provisions by individual section numbers.

The Code is up-to-date through Ordinance No. 453, passed October 8, 2020.

During original codification, the ordinances were compiled, edited, and indexed by the editorial staff of Book Publishing Company under the direction of T.A. Mondragon, Village community development director at the time. The code can be found at [loslunasnm.gov](http://loslunasnm.gov).

## BEEHIVES IN OPEN SPACE

Two new beehives now call the Village Open Space their home after the village acquired them to bring more pollinators into the bosque and to use as an education tool.

Once the bees start producing honey, the Open Space Division wants to bring the community into the process, offering to teach about the pollinators' impact on the environment with processing honeycomb.

The Village Open Space Division was established in June 2007 to meet educational and enforcement needs throughout the Village Parks and Recreation Department.

Part of the Village's Open Space is El Cerro de Los Lunas Preserve which contains over a thousand acres of natural open space.

Park Rangers also carry out conservation efforts to protect plant and animal life from fire, disease, and visitor usage along with historical artifacts.

Park Rangers perform duties that help keep the Open Space safe and attractive.

## SPLASH PAD NOW OPEN

The Los Lunas splash pad is now open at Daniel Fernandez Memorial Park at 1103 NM Hwy 314.

Due to COVID-19 restrictions it was closed to the public after construction was completed. The splash pad is open 10 a.m. to 5 p.m. Tuesday through Sunday during this summer. It is closed on Mondays.

No reservations are needed to use the splash pad which will be on a first-come first-serve basis.

## TAKE CARE DURING HOT SUMMER

It looks like it's going to be a hot summer.

Village Police Chief Naithan Gurule wants to increase public awareness of the leading safety and health risks that increase during the summer months thus decreasing injuries and deaths at homes and workplaces.

Anyone can be at risk for a heat-related illness.

Follow these summer safety tips, like taking extra breaks and drinking lots of water. Moderate your exposure to heat. Take extra steps to avoid being outside for long periods in the sun and heat, especially during the peak hours of the strongest ultraviolet (UV) rays, 10 a.m. to 4 p.m.

Dehydration is a safety concern during summer months. Be sure to drink enough liquids throughout the day, as our bodies can lose a lot of water through sweat.

Use a sunscreen 30 minutes before going out. Reapply sunscreen every couple hours after swimming or working in the heat. Limit sun exposure during the peak of the day.

Stay in shade when possible. Do not leave children or pets in vehicle.

Remember to always have adult supervision for children whether in the pool or playing around water. Having someone to help is essential if an emergency should occur, reminds Chief Gurule.

The Valencia Regional Communication Center (VRECC) dispatched a total of 91,410 calls in 2020.

Los Lunas fire and police represented the highest amount of calls dispatched with 29% of the total calls.

That's an average of 250.4 calls a day and 10.4 calls an hour in 2020.

October was the busiest month for VRECC with 8,254 calls dispatched, averaging 266 calls per day and 11 per hour.

Of the 22,779 calls for service, LLPD responded to, 6,628 were traffic related.
