MAIN/HWY 6 DRAIN COLLAPSE

The drain near the bridge that crosses the Rio Grande on the northeast side of Main Street / NM Hwy 6 collapsed in May 2023 due to erosion from the high levels of water in the ditch and river.

The bridge over the Rio Grande in Los Lunas did NOT collapse, nor sustain any failures due to this erosion.

According to New Mexico Department of Transportation representatives, the Village of Los Lunas had a water main line that was compromised during this drain collapse, however there were no residences or businesses affected by this. The water was re-routed and all customers had access to water.

Judges will be local elected officials.

DON'T WASTE WATER!

The hot months are upon us. Village residents need to avoid wasting water.

Residents should follow Municipal Ordinance 8.24.040 Water Waste Restrictions through September 30.

Spray irrigation is allowed only between 6 p.m. and 10 a.m.

Water waste must not flow onto adjacent properties or public right-of-way whether served by the municipal water utility or by a private well.

Shut-off nozzles are required on any hoses used for hand watering, vehicle or equipment washing, or other outdoor uses.

Water waste restrictions do not apply to:

- Outdoor watering performed with permanent drip irrigation system, sub-surface irrigation, harvested water, or gray water;
- Watering of containerized plants and nursery plant stock;
- Repair and maintenance of irrigation systems;
- Single-day irrigation for application of chemicals for landscape maintenance;
- Non-profit car washes held as fundraisers, if vehicles are washed using handheld buckets and hoses equipped with shut-off nozzles.

Additional restrictions may be applied during declared drought or emergency events.

COUNCIL APPROVES FY 2024 INTERIM BUDGET

The Los Lunas Village Council has approved a \$225,761,757 budget for the Village of Los Lunas for Fiscal Year 2024.

The final budget for fiscal year 2024 will be approved in July 2023 which will cause some of the interim budget figures to change.

The Village forecasts receiving \$211,847,433 in revenues, an increase of \$138,249,217, or 188% from the prior year budget. Major revenue categories are received from gross receipts taxes, intergovernmental grants, and charges for services.

The Village forecasts spending \$225,761,757 in expenditures, an increase of \$133,058,343 or 144% from the prior year budget. Major expenditure categories include salaries and wages, employee benefits, and capital outlay.

The primary reason for the large increase in both revenues and expenditures from the prior year budget is due to the inclusion of the I-25 Interchange / East West Corridor (also known as Los Lunas Boulevard) and parentheses capital outlay project, which is estimated at approximately \$145 million for phase one of the project.

The primary reason for the relatively large difference between budgeted revenues and expenditures is because some revenues have been received in prior fiscal years, and will be used from existing healthy cash balances and the appropriate funds to pay for one-time purchases or projects.

The Village will maintain a minimum general fund cash balance of at least six months of general fund expenditures less any current unexpected expenditures or \$25,294,026, and, in accordance with New Mexico State Statutes, 1/12 (8.33%) estimated available cash reserve balance in the general fund of \$5,459,732.

Employee Salaries

Appropriate employee salary increases have not yet been determined because the Village is currently in the process of completing a Compensation and Classification Study. Employee salary recommendations are expected to be made in the approval of the final budget.

Employee Benefits

The budget includes group health insurance and ancillary insurance through Blue Cross Blue Shield of New Mexico with a rate increase of 0.7% in medical insurance premiums from the prior year.

The budget also includes group dental insurance through Delta Dental of New Mexico with no change in dental insurance premiums and group vision insurance through Davis Vision and Vision Care Direct (VCD) with no change in vision insurance premiums.

The \$225,761,757 budget includes information demonstrating how the Village will use its resources to deliver services and programs to Los Lunas residents, visitors, and businesses.

Budget Highlights

FY 2024 Budget Fund Changes:

1. Created one new Special Revenue Fund:
 - a. Cannabis Gross Receipts Tax Fund (Fund 30) – The cannabis gross receipts tax fund was created to track revenues related to the Cannabis Regulation Act signed into law through HB 2, which passed the New Mexico legislature in March 2021. The cannabis gross receipts tax fund was established by Village Resolution 23-04.
2. Removed one former Fiduciary Fund:
 - a. Regional Dispatch Fund (Fund 45) – The Village of Los Lunas has served as the fiscal agent for the Valencia Regional Emergency Communications Center (VRECC) since June 6, 2006. In 2022, the VRECC Board voted to change the fiscal agent from the Village of Los Lunas to the Village of Bosque Farms, effective July 1, 2023. Therefore, the regional dispatch fund (former Fiduciary Fund 45) has been removed from the FY 2024 Village of Los Lunas budget
