Presentation from All Faiths – by Mica Reagan:

- All Faiths is a behavioral health agency working with at-risk youth, ages 4 to 21, and families struggling with homelessness, family violence, or other types of crises;
- Program services are specific to each child and best practices include participation in the program for 12-18 months;
- Ms. Mica's contact information was provided to the meeting participants.

On-Going Updates:

District Attorney's Office – by Ms. Danae Figueroa:

- New Assistant District Attorney, Mike Ward, has been assigned to the DWI caseload;
- Magistrate Court held its first virtual DWI trial that resulted in a conviction;
- The DA's office is seeing an increase in repeat DWI offenders and fewer DRE cases.

Treatment – by Ms. Joann Cordova-Sanchez:

- There are currently 64 active clients being served by two part-time in-house treatment providers;
- Telephonic sessions continue to work well;
- Some clients who have completed their court-ordered treatment have chosen to continue on with counseling.

By Mr. William Garberina with Full Circle Recovery:

- All continues to go well with Full Circle Recovery;
- Reminder that Adolescent IOP (Intensive Outpatient) is available in Los Lunas and Socorro.

Local/State Law Enforcement Update:

- No updates provided.

Drug Court – by Ragon Espinoza:

- There are currently 17 participants, with a matrix of 30;
- Drug Court is currently seeking a Surveillance Officer; however, adequate supervision of the participants is going well;
- Staffing and Court continue via video platform.

YDI/Teen Court/Youth Coalition Update – By Ms. Victoria Flores:

- There have been no referrals from the court;
- Teen Court received a contract in November and there is hope to begin court again on a virtual platform.

- Working with law enforcement and posting to social media continues to raise the perceived risk of being stopped by the police when there is a great presence of officers in the community.
- DWI Prevention – by Ms. Ginny Adame:
 - PAL/TNT continues to provide evidenced-based curriculum to youth via virtual platform;
 - Collaboration with the Community Wellness Council (CWC) is on-going. 100% Community continues to work to provide a systemic approach to serving the families of our community. Those interested in participating on one of the taskforces should contact Ms. Noelle Chavez, Diana Good or Ginny Adame. Spanish-speaking individuals are encouraged to participate.

Enforcement – by Ms. Ginny Adame:

- Three (3) operations were completed between October and present;
- Citations issued include: 1-DWI; 2-Misdemeanor Arrests; 1-Open Container; 6-No Drivers' License; 4-Careless Driving; 1-Seatbelt Citation; 2-Child Neglect; 1-Runaway Recovery; 23-Speeding Citations; 12-Uninsured Motorists; 3-Suspended/Revoked; 15-No/Expired Registration; 14-Other Citations

Compliance – by Ms. Lori Kurtz:

- Contact with clients continues to be completed by telephone, text messaging, email and video platform;
- The quarterly Misdemeanor Compliance meeting with collaborative partners was not held this quarter due to technical issues;
- The Misdemeanor Compliance Program has served 1,628 clients in the last eight (8) years. 126 clients have returned to our Program, indicating a recidivism rate of 8%. Caveat to this percentage is the clients' return to Misdemeanor Compliance, not to Adult Probation or other supervised program.
