- Treatment medications due include Suboxone, Vivtal and Sublicade.
- Micro dosing with Buprenorphine during a 6 -day period aids in the decrease of fentanyl usage.
- Clients are not required to participate in any mental health counseling.
- They have their own drug testing labs they submit their testing to.
- Drug Testing is done every week.
- Ideal Options does have an adherence schedule:
  - Initiation: Dosage happens 4 x a week for the first 2 weeks
  - Stabilization A: Dosage goes down to 1 x a week.
  - Stabilization B: Dosage goes down to 1 x every 2 weeks and client is provided a RX for 14 days.
  - Maintenance A: Dosage is 1 x every 3 weeks.
  - Maintenance B: Dosage is 1 x month.
- Ideal Options will help set up transportation via the Bus or the Rail Runner. They also offer ticket reimbursement.
- No parental consent is needed for 14 & up.
- The highest percentage of clients are under 21years of age.

### Youth Injury & Violence Prevention Update—By David Adame

- Working on DOH Grant to help with Injury Prevention
- Youth Injury Presentation created based on on YRRS (Youth Risk & Resiliency Survey) and as the survey took place coming off isolating due to COVID the use rate numbers could be off as a result.
- Alcohol use/misuse along with violence numbers are down, according the to the FY21 YRRS, but suicide numbers are up.
- Their goal is to have 50 kids, middle and high school age, to attend the Youth Summit and provide their insight.
- The majority of the youth in attendance at the Youth Summits report that they thought the information on the (YRRS) is not accurate as they believe the substance misuse rates and rates for violence related harms is actually up not down.
- The questions at hand are: What do the kids want? What can we do? What can youth do for change?
- A summary of the evaluation was read by Concha Montano.
- Our schools are failing our youth in providing mental health services and shielding them from violence.
- Parents are home less often.

### On-Going Updates:

- **District Attorney's Office** – by Mr. Scott Bowen, Assistant District Attorney
  - The ADA's office is currently understaffed.
  - Their office is trying to streamline the DWI process.
  - 122.G cases and Officer Prosecuted cases are being referred to their office for prosecution.
  - These cases come with a 7-day Mandatory Jail sentence.

- Joe Harris with the Bosque Farms Police Department advised that getting information from the DA's office has been an issue.
- Questions about possibly scheduling a training to help fill the gaps as officers need to be filled in on new policies was raised.

### **Treatment** – by Ms. Lori Kurtz on behalf of Ms. Joann Cordova-Sanchez:

- 4th quarter v. 3<sup>rd</sup> quarter:
  - Active: 42 v. 65
  - Referred: 26 (LL-22, Bel-2, AZ-MVD-1, Self -1) v. 28 (LL-21, Bel-7)
  - Successful Discharges: 17 v. 11
  - No Treatment Required: 4 v. 3
  - Referred to other Agencies: 6 v. 1
  - Non - Compliance Discharge: 6 v. 4
- Angela is certified for Acu-Detox, a form of acupuncture.
- The program is still a hybrid style due to many clients working out of state; however, working on bringing more clients in-person.
- Their successes include continuing to attend training for their CEU's, working on a schedule for a new curriculum for long-term clients and Angela and Joann were able to enjoy some time off.
- Some of their challenges include no show/no calls by clients, finding the time to complete a resource list and update program forms.

### **Drug Court** – by Ms. Marisha Maez:

- Currently there are 12 participants, with one on bench warrant.
- 1 client will graduate next week.
- 2 clients have graduated since the last meeting.
- Certification is done!
- The Drug Court program is currently working on putting together an alumnus group for peer mentoring.

### **Local/State Law Enforcement Update**

By Sergeant Ryan Gray with Los Lunas PD:

- DRE school went well with 1 deputy passing, Brandon Lujan with Valencia County Sherriff's Office.
- Ryan Gray will assist in obtaining any paperwork that is needed by the court.

By Agent Thomas Bizzell with NMSP:

- Their tobacco operations were a success.
- Warrant roundup operation is scheduled for later this month.

- Hiring a new officer that is certified as a DRE.

### **YDI/Teen Court/Youth Coalition Update** – by Ms. Victoria Flores:

- Teen Court is still being held in person.
- They hosted the NM Teen Conference.

**Prevention/Enforcement** – Presented by Ms. Lori on behalf of Ms. Ginny Adame:

### Prevention:

- Notification was provided by our Local DWI Bureau Chief, Julie Krupkale, that the portion of HB547 (that would have slightly increased the alcohol excise tax rate and would have decreased the % share of the LDWI program amount of the alcohol excise tax from 45% to 40%) was vetoed.
- Continuing with CWC and 100% Community Initiative.
  - CWC has been awarded \$75,000 in Junior House Bill funds from New Mexico State Representative Gail Armstrong to continue coordination of the 100% Community Initiative for FY 24.
  - Additionally, the CWC also received \$9,000 Community Action Grant from Meta for upkeep of the CWC community resource directory, which can be accessed at <https://resourcesvalencianm.org/>.
  - Finally, CWC was awarded \$35,000 from NMSU for the ongoing work and coordination of the 100% Community Initiative.
- Youth Success Core/TNT Boxing & Youth Mentoring Center/H2 Academics/Rocket Teen Center
  - Wrote and received a Youth Injury Prevention Grant for \$59,999.00, which David Adame presented earlier.

### Enforcement:

- Since the last DWI PC on March 8th to present the following operations have taken place:
  - Underage Drinking Taskforce 2 Post Prom Movie Event on 04/15, 04/22 and additional underage drinking patrol on 04/28.
  - The post prom movie events were conducted in support of the Los Lunas High School and the School of Dreams Academy on 4/15 and Valencia, Belen, Century and Infinity High School on 04/22.
  - The post prom sober celebrations took place at Mitchell Starlight Cinema 8 from 11:00pm-3:00AM.
    - These April Operations resulted in the following stats: (5) Felony Warrant Arrests (8) Suspended Driver's License, (2) No Driver's License (3) No Seat Belts, (11) Speeding, and (11) No/Expired Registration, (21) No Insurance and (18) Other Citations.
- In May operations to include Graduation and Underage Drinking Party Patrols took place on 05/18, 05/19, 05/20 and 5/25 with participation from Belen PD, LL PD and VSCO.
  - These May Operations resulted in the following stats: (2) Arrests, (17) No/Expired Insurance, (16) Speeding, (17) No/Expired Registration, (1) Suspended Driver's License, (7) No/Expired Driver's License, (1) No Seat belts, (1) Response to Domestic Dispute, (1) Texting while driving, and (5) Miscellaneous citations.
- A warrant round up will take place later in June and those stats will be shared at the next DWI PC.

### Compliance – by Ms. Cheryl Luna

- Compliances total caseload as of today is 199.
- Compliance attended the Probation Advanced Training in Hobbs, NM
- They continue to work with Argus Private Security Force for the purposes of random drug testing.
