- They are still taking referrals for kids who are 17 and younger or 18 and MUST be in school.
- The Teen Court meets every week and is strictly voluntary for Teen Attorneys and Jury members.
- All 12 youth attorneys work from memory and training, there are no scripts.
- They hold court every 1<sup>st</sup> Thursday of every month in Judge Sichler's court room at 5:30 PM
- The referrals Teen Court sees most are for Possession of Cannabis and Battery.

### B. 2024 Legislative Session Update—By Ginny Adame

- HB179- Proposed by the AHA coalition, this would have raised the alcohol excise tax by 25 cents per drink. This bill did not pass.
- HB213-Which would defund LDWI program and provide cheaper alcohol and cheaper tax, did not pass.
- For the Competitive Grant we asked for \$209,000 vs last year's award of \$179,000.

### On-Going Updates:

#### **District Attorney's Office – By Pamela Saiz**

- The DA's office is short staffed which is leading to more officer prosecuted cases
- The cases that are being referred for officer prosecution include Driving on a revoked license, DWI related.

#### **Treatment- By Ms. Joann Cordova-Sanchez:**

- 3rd quarter VS. 2nd quarter
  - Active: 44 v. 42
  - Referred: 22 (LL-15, Bel-4, Socorro County-1, 13<sup>th</sup> Judicial-1, Curry County-1 ) v. 23
  - Successful Discharges: 8 v. 22
  - No Treatment Required: 4 v. 0
  - Referred to other Agencies: 4 v. 4
  - Non - Compliance Discharge: 1 v. 3
- SUCCESSES
  - The Wednesday group is almost at capacity with 11 attendees
  - Staff continue to have the opportunity to train in other modalities.
- CHALLENGES
  - Personal family issues and health issue
  - Our personal Mental Health Care
  - Identifying which clients are appropriate for the treatment program. We are bound to the program Policy and Procedures to follow the American Society of Addiction Medicine (ASAM) Criteria, which is the Patient Placement Criteria for the Treatment of Substance-Related Disorders.

#### **Drug Court –By Marisha Maez**

- Currently there are 10 participants.
- 1 Pending Probation Violation
- 1 Out of state w/warrant

- 4-new clients pending on Plea & Disposition
- Some members of the Drug Court team will be attending the All-Rise Conference in May in Anaheim, CA.
- Working with Valencia County Detention Center (VCDC) to bring in a MAT, Medically Assisted Treatment, program with the facility. This will give the jail the capability to transport from jail directly to a treatment program.

### Local/State Law Enforcement Update

By Bosque Farm Police Department

- They have their TRACKS program up and running. This will give clearer citations.
- They are working on End DWI and state grants for enforcement.

By Brandon Lujan for VCSO

- Actively working w/traffic for Buckle Up and End DWI
- Upcoming training for Roadblocks.

By LLPD

- 2 check points are scheduled, 1 already completed.
- In compliance with getting their TRACKS program up and running.
- Working on Click it/Ticket it.
- Currently working with a PSA, Public Service Aide, Adrianna Beach, training as Law Enforcement.

### Valencia Shelter Services update -- by Catalina Nunez

- Their FPI class is expanding into Torrance County.
- Currently 49 Referrals total, 21 are new and 19 have graduated.
- There are 14 men and 3 women in their FPI program.
- VSS will be an official SANE location in July, no longer a satellite location to include Torrance, Catron and Socorro counties.
- In 2023 VSS had 1,288 clients, 967 are all new, 132 Forensics interviews and 137 placed in Emergency Shelters.
- Adrianna has left the program to move closer to home while she navigates health issues. VSS should have a new facilitator within the next month.

### YDI/Teen Court/Youth Coalition Update – by Ms. Victoria Flores:

- They are having a Hummingbird Festival on April 27 & 28th.
- They continue to accept referrals.

### Prevention/Enforcement – by Ms. Ginny Adame:

#### Prevention:

- Our program continues to work with Youth Success Core (YSC).
- Prevention continues to work in collaboration with the Community Wellness Council (CWC).
- CWC has a 100% Summit taking place on Wednesday, March 20<sup>th</sup> from 9am-3pm.
- Ongoing recruitment for the 10 Action teams.

### Compliance – by Ms. Cheryl Luna

- Compliances total caseload as of today is 167.
- Compliance attended the Ad hoc meeting in Dona Ana County in Las Cruces
- The Ad-Hoc committee is working hard to have the MVD and Ignition Interlock program attend our meetings on a regular basis, so we all understand the requirements of each agency.
- The transition from Interlock License to regular Driver's License can be very frustrating.
- Compliance continues to work on the Risk-Needs-Responsivity (RNR) Framework Pilot Project in conjunction with AOC along with completing the ORAS.
- To date compliance has completed approximately 32 DUI-RANTS and 24 ORAS.

### Open Discussion/Topics for Next Meeting:

- A push to get the NM Survey Completed was discussed. The survey is available on-line and in English and Spanish.
- Possible training with the ADA's office and Law Enforcement to work on conviction rate. It currently sits at less than 50%.
