#### New Business:

##### **A. Family Peace Initiative Presentation by Araceli Garcia-Galaviz, FPI Facilitator**

- FPI is a trauma focused Cognitive Program
- The purpose of the program is to help victims and their families.
- It is a 52-session program with a class every week and is peer lead.
- Male group has 18 participants and meet on Wednesday nights at 5:30 PM.
- Female group has 5 participants and meet on Thursday nights at 5:30 PM.
- VSS has a progress and compliance tracking system, along with case management for support w/drug addiction, parenting support, individual and family counseling.
- Per DVOTI, VSS FPI program has a 65% success rate.
- Ages from 24-44 are the dominant age range.
- A HUGE thank you to the DWI Program for the \$40K funding. This funding will help create another women's FPI group, additional make-up group to come 6/21/2024, and new program materials.

### B. Review and Approval of By-Laws – By Ms. Ginny Adame:

- Section V: Membership, Letter D -- Ms. Ginny recommended removing the comma after the word President and adding the word 'and' and removing the words 'and Secretary' from the by-laws, due to not having a secretary position currently.
- The first sentence of Section V: Membership, Letter D will now read, 'The DWI Planning Council Executive Board shall choose a President and Vice President from among its membership'.
- Motion to accept the recommendation as presented was moved by Karen Sullivan and 2<sup>nd</sup> by Carol Claus.

### On-Going Updates:

#### District Attorney's Office – By Pamela Saiz:

- The DA's office hired two new attorneys. One primarily in magistrate court and one on felony cases.
- Their office is working on Pre-Trial Detention Motions, which works to keep defendants held on their current charges until their court date to help reduce that defendant picking up new charges while pending trial.

#### Treatment- By Ms. Cheryl Luna for Ms. Joann Cordova-Sanchez:

- 4th quarter VS. 3rd quarter
  - Active: 52 v. 44
  - Referred: 41 (LL-26, Bel-10, Texas-1, Illinois-1, Arizona-1, 13<sup>th</sup> Judicial-1, Curry County-1) v. 22
  - Successful Discharges: 8 v. 8
  - No Treatment Required: 4 v. 4
  - Referred to other Agencies: 4 v. 4
  - Non - Compliance Discharge: 1 v. 1
- SUCCESSES
  - The Treatment Policy and Procedures have been updated.
  - Two clients completed treatment and have elected to stay for Aftercare.
  - Joann and Angela completed their required First Aide/CPR/AED program.
- CHALLENGES
  - Building up the groups again, probably due to it being summer, more people wanting to work on personal issues in individual sessions.
  - Joann will be out 1-2 weeks and Angela will be facilitating both groups. Joann will be working from home.

### Local/State Law Enforcement Update:

#### By Los Lunas PD:

- Last month the department concentrated on mobile saturation instead of DWI Check Points.
- In 36 hours, 4 hours per officer, 1-DWI arrest was made, and it was a repeat offender. This arrest included a use of force and a warrant for blood draw.
- The department is seeing DWI's during the day involving Fentanyl and DWI's during the evening are more alcohol involved.
- Standard check point is 5 hours.
- DWI's are more drug related, specifically Fentanyl. Usually, the vehicles are not on the road. The vehicle is usually pulled over and the driver is unconscious.
- Trying to obtain a blood draw has been a challenge.
- There are not a lot of DWI's that are cannabis involved.

#### By Isleta PD:

- Their offices have been pro-active, having 11 DWI's since May.
  - 6 of them non-tribal, just passing through
  - 10 were aggravated
  - 8 Refused the breathalyzer
  - 1 was a simple DWI
- Their department has a checkpoint scheduled on Hwy 45, which tends to be a problematic area.
- In May they had 7 DWI checkpoints, with no DWI's arrests.
- Checkpoints will continue through summer.
- Their Click IT or Ticket is in full swing, their department is on foot looking for any violations.

### Valencia Shelter Services update -- by Ms. Catalina Nunez:

- Their name has changed to VSS, Serving Central New Mexico.
- They have a satellite office in Torrance County, 505-339-6943.
- Their shelter is ½ full, so they have space. Currently they have 10 families in the shelter and 1 male in a hotel.
- The SANE location, here in Valencia County, should be up and running by 07/1/2024
- They are in the process of hiring a medical coordinator and nurse.

### YDI/Teen Court/Youth Coalition Update – by Ms. Victoria Flores:

- Teen Court is having a BIG celebration on 06/27/2024. Their Teens are taking their oath. They will enjoy lunch at the China Buffet and enjoy discounted tickets and free popcorn and drinks at the Sunshine Movie Theater.
- The Teens continue to volunteer their time, every Thursday night from 5-7 PM.
- They currently have no funding at this time and are unsure if funding will come through.
- Despite that, they continue business as normal.
- It costs anywhere from \$20-30K. That money helps with assessments, meeting with parents, feeding the teens, and training.
- 1 teen attorney was hired at a local attorney's office.

- 1 new teen attorney and 1 graduated.

### Prevention/Enforcement – by Ms. Ginny Adame:

#### Prevention:

- Our program continues to work with Youth Success Core (YSC).
- Prevention continues to work in collaboration with the Community Wellness Council (CWC).
- 24 youths have successfully completed the YSC 10-week program.

#### Enforcement:

- Since the last meeting in March the Underage taskforce conducted a joint enforcement operation on two nights. Joint statistics include:
  - 1 Minor in Possession
  - 2 Arrested on a Warrant
  - 1 Driving on Suspended/Revoked License
  - 4 Driving without a License
  - 8 No/Expired Registration
  - 20 No Insurance
  - 11 Speeding
  - 25 other Citations
- The remaining two operations took place on May 18<sup>th</sup> and June 11<sup>th</sup>. Joint statistics include:
  - 1 Minor in Possession
  - 1 Open Container
  - 2 No Seatbelt
  - 13 Speeding
  - 11 No Insurance
  - 6 No/Expired Registration
  - 2 Driving without a License
  - 1 Driving on a suspended License
  - 18 other Citations
- Bench Warrant (B/W) round-up was completed with no successful arrests, mainly due to clients either moving out of state or not having an updated or valid address. In addition, not having access to NCIC to confirm B/Ws is difficult, but the Sheriff's Office reached out and volunteered to assist in validating the warrants.
- The prom event was a success with approximately 150 attendees on the April 13<sup>th</sup> event and approximately 75 at the April 28<sup>th</sup> event.

### Compliance – by Ms. Michelle Gonzales:

- The total caseload as of today is 145. Ms. Cheryl has 89, Ms. Michelle has 43 and Ms. Lori has 23. Ms. Lori covers the Spanish-speaking Clientele. Cases being sentenced out of Belen Magistrate are increasing.
- The compliance Team has been meeting weekly to review policies and procedures in preparation for their assessment for Reaccreditation in June 2025.
