**New Business:**

**FY 2018 LDWI Award Totals and Impact on Programming – by Ginny Adame:**

- Deep funding cuts of \$155k in FY 2017.
- Budget cuts in upcoming FY 2018 leave no funding for enforcement services; creating huge loss. Actively searching for additional Grant funding;
- Program Coordinator meeting hosted in Taos to be held June 21, 2017; possible announcement regarding the future placement of LDWI programs by Rick Lopez.
  - Bart Regelbrugge requested copies of Quarterly reports to share with his contacts.
  - Program efforts acknowledged by Diana Good.
  - Spending more time to focus on seeking additional Grant funding for sustainability.
  - Advertising by DWI programs was frozen by State DWI Planning Council.

**Presentation PAL– by Desi Garcia:**

- Recruited (60) kids – Graduated (60) kids.
  - Groups of (30) kids over (5) weeks – (2) summer camp sessions.
  - Partnered with TNT Boxing, LL Open Space, and LLLPD.
  - Youth Softball tournament raised \$1,000.
  - Grant funding exhausted with little left for funding.
  - Continue recruiting in LL schools.

**On-Going Business:**

**YDI/Teen Court/Alcohol Density Youth Coalition Update – by Crus Munoz:**

- July 2016-June2017;
  - (39) clients

- 75% being male – 25% being female
- Rise in alcohol related offenses
- July 13, 2017 next teen court
- Viva Tu Vida on July 29, 2017
  - Provide free backpacks for new school year (300 bags handed out previous year)
  - Attendance high last year with 1,000+ people.

**Drug Court** – Mr. Ragon Espinoza reported:

- Attended Drug Court Coordinator training in April hosted in Reno, NV.
  - (15) Participants in Drug Court program.
  - (2) Participants are in custody awaiting acceptance of inpatient treatment services.

**District Attorney’s Office** – Mr. Joshua Jimenez reported:

- Currently compiling numbers for April-May.
- Introduction of new Assistant District Attorney, Savannah Brandenburg, who is handling DWI cases at both Belen and Los Lunas Magistrate Courts.
- Turnover of A.D.A personnel has decreased.

**Prevention/Enforcement** – Ms. Ginny Adame reported:

- Prevention:
  - Community Wellness Council (CWC) hired part-time Coordinator/Grant Writer focusing on: access to quality health/mental health services/care, prevention of Substance Abuse, and reduction of ACES.
  - Reporting data of the longer spans of time is limited due to lack of participation in Prevention services.
- Enforcement:
  - Nothing to report due to lack of funding.

**Alternative Sentencing/RMOMS** – Ms. Lydia Duarte reported:

- Management position has been filled by her (Lydia).

**Treatment** – Ms. Jennifer Sandoval reported:

- Provided stats for the 4<sup>th</sup> quarter through today’s date;
- Acudetox services has decreased lately.

**Compliance** – Ms. Lori Kurtz reported:

- Increased number of probation violation packets filed by CM staff.
- Increased use of warm-line services.
